How the system works?

PATIENTS

- Patients can upload their previous prescriptions, medical records, test reports etc into the system software.
- They can book appointments for offline or online consultation with the doctors registered into the system and make payments online.
- They will receive meeting link in their sms/email for online consultations which they need to join to connect with the doctor.
- They will get their prescriptions through the system after any consultation.

DOCTORS

- Doctors can set consultation date and time though the system.
- Doctors can view medical records of all the patients who have booked an appointment with him.
- Doctors can create video conference through the system and send meetings links to patients who have booked the appointment with the click of a button.
- Doctors can create prescriptions for patients post consultation with integrated WHO's ICD-11.
- Doctors can access patients's medical records/prescriptions from anywhere around the world at any time.

CLINICS

- Clinics can add different doctors in the system who are available for online/offline consultations in their clinic.
- Clinics will be able to set consultation dates/time for the added doctors and also set their fees.
- Clinics will be able to send follow up emails and sms to the patients from the software.
